

## HSBC Expat Bank Account Opening Requirement

### HSBC Expat Premier

1. maintain a minimum balance of £50,000 *or*
2. have a sole salary of £100,000 *or*
3. have already qualified for HSBC Premier in another country (eg. Singapore, Malaysia)

Latest Updates : HSBC Expat no longer offers the choice of maintaining £15k as a min. balance requirement. Hence, you have to meet either 1 of the requirements as above-mentioned.

### **Notes:**

1. Crestbrick will connect you with HSBC Expat Team via email.
2. Approximate 2 weeks progressing time
3. Crestbrick will not be able to assist on your application if is apply by yourself through website or through your own Relationship Manager

HSBC UK Bank Account Opening has **no salary or minimum balance requirement.**

**Option 1 :**

1. Request a call back from International Team <https://internationalservices.hsbc.com/call-back/>
2. After the call with them, they will send you an application form.
3. Follow their instructions and print out the required documents to the nearest HSBC Branch
4. S\$150 fee is payable over the counter in order to open your account successfully.
5. Upon approval, HSBC UK will mail you a card with your bank account details and internet banking activation.
6. Please follow their instructions or call to HSBC UK to active your internet banking.

**Notes:**

1. Approximate 6-8 weeks processing time
2. If you need to call HSBC UK, please use Skype credit. Cheaper than normal telco.
3. Bank account opening process subject to HSBC guidelines.

HSBC UK Bank Account Opening has **no salary or minimum balance requirement.**

### **Option 2 :**

1. You need a HSBC Singapore Bank Account (Eg: Everyday Global Account, S\$2,000 min balance needed)
2. After you have opened the HSBC Singapore Bank Account, please head down to HSBC Singapore Branch and request for HSBC UK Bank Account Opening. Reason : I have a UK property.
3. They will need you to fill up and sign on a form to get HSBC International Team to contact you.
4. Please wait for the email or call from HSBC International team
5. They will go through the bank account opening process with you through phone call
6. They will send over your application form and requested documents to you via email
7. Please follow their instruction accordingly and visit Singapore Branch to submit requested documents.
8. S\$150 fee is payable over the counter in order to open your account successfully.
9. Upon approval, HSBC UK will mail you a card with your bank account details and internet banking activation.
10. Please follow their instructions or call to HSBC UK to active your internet banking.

### **Notes:**

1. Approximate 6-8 weeks processing time
2. If you need to call HSBC UK, please use Skype credit. Cheaper than normal telco.
3. Bank account opening process subject to HSBC guidelines.
